

#### How did the Fund perform during the reporting period?

Throughout the reporting period, THIR diversified amongst U.S. indices to provide an "index-like" investment experience, with the enhancement of additional exposure of certain indices in times of strength, or decreased exposure during times of market volatility. In the fall of 2024, THIR took advantage of strength in the tech sector from AI with increased exposure to the NASDAQ (QQQ). As we moved into the end of the year, THIR spread its exposure equally across the three main indices to spread exposure across the vast array of the market landscape. During the spring of 2025 the overall market experienced significant weakness from the threat of large global tariffs to be imposed from the U.S. Administration. THIR completely removed equity exposure during this time, significantly reducing downside volatility for about one month. As the dust settled and tariffs were delayed, THIR immediately replaced its equity exposure equally across the three main U.S. indices and has maintained this positioning through the course of the reporting period as the market continues its rise from the spring.


